### DABC Kicks Off Free Tax Preparation Services on January 30<sup>th</sup>

January 20, 2010 – The Denver Asset Building Coalition today announced the hours for its Free Tax Sites, where families earning less than \$49,000 can receive federal and Colorado tax return preparation services. With services at the King Trimble Center and Wells Fargo in Aurora, clients can get their tax returns filed electronically during convenient after-work and weekend hours, and receive their refunds within seven to ten business days.

Other services include establishing free checking accounts, and purchasing savings bonds using tax refunds. Spanish language assistance is available at both locations.

Extended hours will be available on special Earned Income Tax Credit (EITC) Days. “On EITC days, DABC offers extended hours to enable as many people as possible to take advantage of our services and ensure hard-working families can claim the full EITC to which they’re eligible,” said John Russell, DABC Executive Director. “The EITC is a powerful work incentive and antipoverty tool, which provides additional income to families earning less than \$43,279, depending on number of children, and to individuals earning less than \$13,440. The EITC can provide eligible families with as much as \$5,657 in additional income.”

“Unfortunately, many Coloradans don’t realize they are eligible for the EITC and fail to file their returns, and millions of dollars go unclaimed each year,” added Russell. “With our tax sites, DABC is working hard to enable as many families as possible to claim the credit. In addition, the community benefits from the influx of EITC dollars.”
